that the information age has exploded through technology, people get their information from any number of sources, TV, radio, computer. The same feeling, that the newspaper industry was not going to exist when the radio and television came on to the scene. What made the difference was relevance. Today the large metro newspapers are struggling because it is difficult for them to find relevance with their readers. The small home town papers are more important to the community. The community still relies on this print media to get local news; high school sports, city hall news and community news. The smaller the paper the more important.

Will it be around? Yes. 72-76% of the information on the internet is generated from newspapers. The market will dictate what the industry will do. There will be some who will use the website but there will be the print media. "The Times" website is the heaviest used and because of that they are in the process of rebuilding the site. You can receive constant weather updates and you can even watch local high school sports. You can receive the entire newspaper on the website by subscribing e-edition. This includes all of the ads
