volunteers work every week with more than 50 volunteers working every weekday on routes that typically have 16 stops. In addition to numerous individual volunteers, 32 organizations in NWI provide volunteers to work the noon hour one day each week or month. The Merrillville Rotary Club is one of those organizations that works one day every month. Some organizations also sponsor individual meals or even whole routes. MoW operates out of a 3 year old facility in Merrillville with drop-off points in Hammond at the Robertsdale Fire Department and Tri-Electronics. Private-pay clients pay \$4.25 for a hot meal or \$3.00 for a light supper snack. Nearly 50% of the meals are indirectly subsidized by the federal government through the Older Americans Act. One of the important side benefits of the program is that volunteers often serve as a daily monitor for the sick and elderly who have no one else to check on them.
