Dave's last was in 1985 to a rugby so he said he might be a little rusty. He gave us some family and business history. His great grandfather moved here from Wisconsin as this area had jobs available. He had a partner and opened a business first on Hohman Avenue, then on Hohman & Sibley until 1902. They moved to the current location in part due to a broken engagement and a breach of contract lawsuit that involved the daughter of the owner of the previous location. Hasse was a saloon owner next door but when moved Mueller bought his space and expanded his shop. Initially the hardware store had a side business that was very significant in sheet metal work. Following the depression, a change was made and the side business became

Dupont Automotive Paints. It remained a vital part of the business until 2006. If you had asked Dave 10 years ago if he would ever get into the arts business he would have thought you were crazy.

Since the opening of Substation No. 9 and the Towle Theatre, he has had the opportunity to re-think that idea. He opened the gallery last fall and he was very clear about the fact that he needs patrons not just visitors. He represents more than 100 artists and his price range is from \$5 to \$40,000. He also told us a very unusual story about the first piece of artwork he ever displayed in the hardware store and how he was threatened at gunpoint by a local "artist" to get him to display it. Questions and comments followed from the Rotarians about remembering the importance of supporting Hammond businesses and also the idea of having a Hammond Rotary event at the Gallery.
