President Sanger introduced Jim Alvarez, our guest speaker who talked about technology and fundraising. Jim works for a six year old technology company called Auctions by Cellular. This is a company that can do a silent auction by cell phone.

Peyton Manning told them he had people that he would meet who wanted to give money to his foundation but he had no way of taking credit cards when he was out in the public. Auction by Cellular was able to build a platform where a person can text a password, follow the prompts, and donate up to \$1,000,000 to the foundation.

Silent Auctions can also be done by cell phone. It took two years to develop, but it was launched last May. When people come to a silent auction event, they are asked their first and last name and cell phone number. The cell phone must have text ability. Everything is automated. A person simply texts the item number and within three minutes they are notified that they are the high bidder. When they are outbid, they are notified by text. People can also bid from their seat and they are having tremendous success with older folks.

They have done 153 events so far and 100% of the time, they have helped the charity raise more money. Guests that cannot come to the event can still participate from home.

By using a cell phone, you do not know who you are bidding against. People tend not to outbid a priest on a silent auction item or a celebrity, such as Michael Jordan. Using a cell phone, you do not know who you are bidding against. At an event in Indianapolis, a husband and wife were bidding against each other and didn't know it. Instead of paying \$350 for an item, they paid \$800.00. The wife won and the money went to the charity.

Auctions by Cellular is having great success streamlining events. The moment the silent auction ends, receipts are printed and people are able to check out within five minutes of the auction closing. Credit cards can be scanned so the charity can get their money with 10 business days. At golf outings, golfers can start bidding as soon as they arrive.

There is a fee structure for this service depending on the number of people and number of items. It is totally customized.

Jim also has 145 volunteers from 11 different high schools in Porter County and is looking for a charity to connect with. Jeff recommended that Jim contact the Porter County United Way and Lisa Woodruff recommended he connect with theater groups.
